### Manager's Report

#### **Roofing Update**

Roofing project is on schedule. In response to ownership inquiry, Linda received a bid from Guerrero Roofing to replace the roofs on the dumpster houses. Discussion was held and it was decided that the roofs on the dumpster houses will not be replaced at this time.

# Railing Update

A4S LLC has inspected all of the decks and owners have been notified of any repairs necessary prior to railing replacement. Additionally, A4S LLC determined that five posts need to be replaced. Final pricing for the post replacement is being submitted. A/R for railing project was reviewed by BOD and discussion was held regarding upcoming payment deadlines and assessment of penalties for late payments. Owners that have not paid their assessment for the railing project in full will be notified before the July 1st deadline of the penalties that will be assessed for nonpayment by the July 1, 2013 date.

### Carpet & Painting

Hallway carpet for Building H has been ordered and will be replaced on schedule. Hallway painting in Building K-east and Building H have been completed. Hallway painting in Building J is on hold.

#### Pool

Landscaping for pool has been completed and deck chairs will be replaced as needed. Leak from abandoned line was discovered. Linda will arrange to have both the abandoned line and the line to the pool shower capped. Peter made a motion to have the pool fence stained with a natural waterproofing finish to prolong the life of the fence. Joy seconded the motion. Motion carried. All in favor: 7:0.

## Non-smoking policy

# **Parking Lot**
