

RISK MANAGEMENT CORNER

How To Protect Your Home From Washing Machine Water Damage.

Your washing machine is one of the most common sources of water damage in the home! Take these steps to prevent water damage:

- 1. Follow the manufacturer recommendations. Do not overload the machine and use a detergent that is designed specifically for your machine.
- 2. Do laundry when you are home. If the machine malfunctions, at least you will be able to turn it off and manage water issues immediately.
- Replace hoses on a regular basis (at least every 5 years). If you pull the machine out for cleaning or maintenance, make sure you don't crimp the hoses when you put it back.
- 4. Put a "catch pan" under your washer.
- 5. Install a smart home water sensor so you can detect leaks as soon as they occur.




Water Saving Tips:

Turn your faucet ALL THE WAY TO HOT right away when calling for hot water.

Turn the faucet off while brushing your teeth.

Run your dishwasher only when it is full.

Adjust the water level in your clothes washer to the size of your load.
